 - a. The singular includes the plural and vice versa;
 - b. References to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "Including" is understood to mean "including without limitations";
 - e. Reference to any statutory provision includes any modification or amendment of it;
 - f. The headings and sub-headings do not form part of this privacy policy.

Scope of this Privacy Policy

- 3. This privacy policy applies only to the actions of Enviroboards Ltd and Users with respect to this website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide.
- 4. For purposes of this applicable Data Protection Laws, Enviroboards Ltd is the "data controller". This means that Enviroboards Ltd determines the purpose for which, and the manner in which, your Data is processed.

Data Collected

- 5. We may collect the following Data, which includes personal Data, from you;

How We Collect Data

- **6.** We collect data in the following ways:

Data that is Given to us by You

- 7. Enviroboards Ltd will collect your Data in a number of ways, for example:

In each case, in accordance with this privacy policy.

Data this is Collected Automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. We automatically collect some information about your visit to the Website. This information helps us to make improvements to the Website content and navigation.

Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
 - a. Internal record keeping;

- c. Transmission by email of marketing materials that may be of interest to you; In each case, in accordance with this privacy policy.
- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your Rights" below).
- 11. For the delivery of direct marketing to you via email, we'll need your consent, whether via an opt-in or soft-opt-in:
 - a. Keeping Data Secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. Access to your account is controlled by a password and a user name that is unique;
 - b. We store your Data on secure servers.
- 14. Technical and organisational measures to deal with any suspected Data breaches are in place. If you suspect any misuse or loss or unauthorised access to your Data, please let us know immediately by contacting sharlene@enviroboards.co.uk

Data Retention

- 15. Unless a longer retention period is required or permitted by law, we will only hold your data on our systems for the period/s necessary to fulfil the purposes outlined in this privacy policy or until you request that the data be deleted.
- 16. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your Rights

- 17. You have the following rights in relation to your data:
 - a. **Right to access** The right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this. Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
 - c. **Right to erase** The right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. **Right to Data portability** the right to request that we move, copy or transfer your Data.
 - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.

- 23. We may also disclose Data to a prospective purchaser of our business or any part of it.
- 24. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

General

- 25. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonably believe your rights will not be affected.
- 26. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that the provision or part provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 27. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 28. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
